	<p><b>Meeting commenced at 7.00 pm.</b>  S.Jackel opened the meeting, and thanked everyone for attending. G.Slocombe advised the purpose of this special meeting was to review the nominations received for membership recognition.</p>		
1	<p><b>Present/Apologies</b>  The secretary called for apologies which were noted.</p>		
2	<p><b>Review of constitutional guidelines</b>  G.Slocombe reminded the committee of the constitutional guidelines and criterion for awarding of membership recognition onto the membership honour board.  It was also agreed that whilst not specifically called out in the constitution, sitting committee members should not be able to be awarded such recognition. Instead a future committee service board should be considered to capture records of service in time.</p>

<p><b>4</b></p>	<p><b>Definition of ‘founding member’</b></p> <p>For the purposes of clarity, G.Slocombe proposed that a founding member shall be defined as;</p> <ol style="list-style-type: none"> <li>1. A person named on the original Chapter formation paper work submitted to ACMOC;</li> <li>2. or a person that attended the informal meeting at the November 2014 rally meeting;</li> <li>3. or a person that attended the first official recorded Chapter meeting for the formation if a committee on 22<sup>nd</sup> November 2014.</li> </ol> <p>While records exist for items 1 &amp; 3, beyond photographic evidence there is no official attendance records for item 2. Therefore any claim for founding member status would need to be taken on its merits at the time.</p> <p><b><i>Motion: That the definition above for ‘founding membership’ status be employed.</i></b></p>	<p>Moved: GS Seconded: MH</p> <p><b>Motion passed unopposed</b></p>	



